1. Call to order:

2. Engineer's Business:

2A. Ryan Smith will discuss the Engineers Report.

2B. Ryan will answer any questions the Board may have concerning the status of various projects in the district.

2C. Discussion/vote: to take action concerning the DWSRF Bixby Zone Disbursement Request No.8 in the amount of \$402,347.46. Authorizing payment to Cook's Consulting for \$370,599.74, to Poe Engineering for \$31,747.72, and authorize Board President Harvey Morris, and District Mgr. Cindy Hubbell, to sign the Disbursement Request.

2D. Discussion/vote: to take action concerning a utility relocation agreement with ODOT for the US75A roadway improvements project between Kiefer and Mounds. The Agreement to include either like-in-kind relocation of facilities for no costs to the District or betterment to 6" for a cost of approximately \$314,502.62 or the 8" option, the estimated out of pocket costs are \$724,661.29.

These costs include construction, engineering, ODEQ permitting, and advertising.

And authorize the Board President Harvey Morris, to sign the ODOT agreement.

2E. Discussion/vote: to take action concerning a rebalance of accounts in the amount of \$750,000.00, to fund the Capital US75A Roadway Improvements ODOT Project.

2F. Discussion/vote: to take action concerning the US75A IPO 4 - an engineering agreement with Kimley-Horn to complete the US75A project from Kiefer to Mounds for cost plus, the maximum not to exceed the labor fee of \$319,200. (It allows for whichever one the board decides whether it is a 6" or 8" line.)

2G. Discussion/vote: to take action concerning Amended Permit No. WL000019220623 for the construction of 1,323 linear feet of six-inch (6") PVC potable water line and a small relocation of 316 linear feet of six-inch (6") PVC potable water line and all appurtenances to serve the Bennett Dairy Estates, Creek County, Oklahoma.

2H. Discussion/vote: to take action concerning participation in the Memorandum of Agreement for Project OK 21-W53 executed by the Indian Health Service and the Muscogee Nation on July 14,2021 and allow for the construction of a 400' waterline extension to serve Soma Learned and allow Board President Harvey Morris to sign the revised agreement.

2I. Discussion/vote: to take action concerning a semi-annual payment to the Water Resources Board in the amount of \$28,423.43, for Construction Loan #ORF-19-0015-DW of which \$4,242.34 is for Administrative Fees and \$24,181.09 is for interest on the construction loan.
