FILING REGISTRATION FORM FOR BOARD POSITION

Adopted March 10, 2009

Any qualifying member of the District who desires to serve on the Board of Directors must file at the District Office his/her intent to run for a position on the Board of Directors. This will be done by completing a Registration Form during the filing period from October 1st through November 1st for the election to be held at the following Annual Meeting of participating members. Each candidate filing for a position must indicate on the Registration Form for which position vacancy he/she is filing. Provided further, any incumbent Board member wishing to run for re-election must also complete a Registration Form during filing period previously stated and meet the same qualifications as a new candidate.

Any newly elected Board Member shall be required to attend a minimum of six (6) hours approved training and shall pledge to attend such training at time of registration as a candidate. Said training attendance shall be completed prior to Director's first anniversary on the Board.
